(Farmers' Empowerment towards Livelihood and Conservation Intervention in targeted villagers and Protected area)

HELD AT: Bordoloni LP School, Dathkola, Bakori Doloni

DATE: March 19th 2018 at 1:00PM

District Community Development Programme (DCDP) organized a Project Appraisal Workshop in collaboration with WWF-India, Assam Landscape, Tezpur on March 19th 2018 at Bordoloni LP School, Dathkola under Halem revenue circle, Gohpur sub-division of Biswanath District in Assam.



There were all together 36 kev leaders from Gopal Jharoni. Thute Sapori, Toltoli and Dathkola area participated in the Workshop. The Secretary Kretofil Bhengra welcomed all the participants

and briefly highlighted about the objectives of the Workshop. He has also elaborated about the details scenario of the project proposal which was submitted during the Project Screening Workshop held at New Delhi during October 30th -31st 2017 and the suggestions made by the Expert Committee regarding revisiting the Proposal and which need to be submitted before March 25th 2018 to the department of Science & Technology, New Delhi.

Consequently the Workshop moderated by Mr. Ram Kumar Prodhan a prominent Social Worker and there were several comments and suggestions came out for discussions. Mr. Dibyajyoti Khorel (MSW) also stressed on his speech about the feasibility of these four villages. He has briefly elaborated the scope for Livelihood

opportunities in the area. He mentioned about Farming activity like Fishery, Poultry cum Duckery, organic farming, handicraft are the feasibility and there is possibility for the market linkages. Same way Basudev Kutum from thute Sapori, Dibadhar Pegu, Deva Deka from Gpal Jaroni, Luknath Sharma from Dath Kola



and other social workers also shared their views and appreciated DCDP and WWF for initiative of such project in the area. After prolong discussions a grass root level project monitoring committee with 17 members has formed by the participants covering four villages for sustainability of people's action for development.
