Activities carried out during the period

April - 2016 to March 2017

Background: Sonitpur District is a heart of state of Assam comprising three sub-Division-Tezpur, Biswanath and Gohpur and now from the last 2017 it is divided into 2 districts Sonitpur and Biswanath District.

District community Development Programme (DCDP) carried out the following activities during the period of April-2016 to March-2017

Presently we do not have any direct supported project since April 2015th however with local contribution the following activities are undertaken through the active participation of the community level and the office bearers of the Governing Board of Organization.

Governing Board Meeting: There are 13 members in the Governing Board and 3 executive meetings conducted during the period. The following decisions were taken in the meetings-

- 1. Proposals should be prepared on Food Security schemes and to submit to the Ministry respective department. The President and Secretary is entrusted to workout and do the needful.
- 2. The Secretary is entrusted to go for online registration under NGO PORTAL, Nity Ayug to get the Unique ID.
- 3. The Secretary and President entrusted to accept the project from SEVA Bharat and implement the Adult Literacy Programme in Halem Circle as per data collected from the community.
- 4. The Local Contribution should be raised towards developmental activities from the well wishers, Community and other sources like other likeminded Organizations, Government.
- 5. The Secretary is entrusted to communicate Public Health department for Construction of Individual Household Latrine as per the survey list.

1.1. Renewal Of the Organization:

The renewal of District Community Development Programme is completed and now it is valid for three years till 3019.

The renewal for the Foreign Contribution Regulation Act also completed and validity extended for 5 years.

World Environment Day: DCDP organized World Environment Day in collaboration with Bheluadanga LP School. There were 100 tree plants distributed among the children and planted in the School Campus and in the Campus of Karibil GP Office. The programme followed with singing by the students and drawing competition were conducted during the programme. The Head master Mr Noropati Bhatrai and Mr. Kretofil Bhengra elaborated about the Environmental impact assessment and bringing creative thoughts for healthy society with green Environment. Our attitude and accountability towards Preservation and protection of our Environment are the most

important. The Children of the school enthusiastically participated in the completion.

Children Development Programme:

District Community Development Programme felt the need to promote education and health status among the Children from class 1 to class Viii (Eight). There are many children in the area who are spending time for un reasonable activities after their schooling time. This is happening due to lack of education of their parents or guardian. Therefore DCDP took the initiative to impart knowledge and keep them busy on their study at DCDP campus. There are 41 Children in the Children Development centre with 1 facilitator and 4 Assistants who are honorary serving and taking care of these children. Through this initiative children are regularizing on their study, gradually improving their habits and improving on how to read and write also in health status. This programme is regular basis from Wednesday to Saturday in a week. Following facilitator and Assistants are devoting time in the centre.

Mr. Kretofil Bhengra on behalf of DCDP participated in the workshop held on March 4-5, 2017 at Rishikesh and presented the Concept not on the Project for People and Protected area based on Conservation and Sustainable Livelihood in partnership with Local Communities.

FSSAI Renewal: DCDP has done renewal of its License of Food supply under Food Safety Standard Authority of India and extended its validity from 14th September 2017 to 13th September 2018.
